Sub : Establishment of a new Degree College named as Netaji
Satabarshiki Mahavidyalaya at Asnokenagar in the district
of North 24-Parganas.

The undersigned is directed by order of the Governor to say that the Governor is pleased to approve of the proposal for the establishment of a new Degree College named as Netaji Satabarshiki Mahavidyalaya at Asnokenagar in the district of North 24-Parganas with effect from the academic session 2000-2001 subject to the following terms and conditions:-

- i) The organisation shall be required to provide land, by way of registered deed, free from all encumbrances in favour of the college authority.
- ii) The organisers shall be required to provide at their own costs, adequate accommodation for classes, office rooms, teachers' room, principal's chamber and essential furniture, equipment, Books etc. for the purpose of the college. In case of delay in constructing the permanent building, the organisers shall be required to construct temporary structure consisting of at least five rooms.
- iii) Adequate arrangement shall be made for supply of drinking water, separate toilets for male and female students and members of the staff.
- iv) The college shall not be permitted to run Higher Secondary Course.
- v) The college shall be run in the manner prescribed in the Statute of the affiliating University. No special constitution of the Governing Body shall be allowed.
- vi) Terms and conditions for the purpose of affiliation laid down by the University are to be fulfilled.

The college may for the present be affiliated to B.A. (Pass) with the subjects viz. Bengali, English, History, Political Science, Sociology on a self financing basis subject to the condition that no subject should be opened unless than 30(thirty) enrolments should be opened.

The Governor is also pleased to approve the creation of the following posts in the usual scale of pay with effect from the date of filling up the posts during the current academic session :-

Teaching staff shall be appointed on the recommendation of the West Bengal College Service Commission and recruitment to non-teaching posts shall be made subject to observance of the recruitment rules prescribed by the Government and the provisions of the statute of the affiliating university. The candidate to be appointed to the post of Cashier should hold a B.Com. degree holder.

Non-teaching posts as mentioned above should be filled up on a temporary basis on fixed remuneration per month at the initial of the lowest scale of pay without any allowances for a period of one year.

The charge on account of payment of grants towards salary of the staff of the college will be met from the provision under the head, "2202-Other Education-03-University and other Higher Education-900-Other Education-State Plan (Annual Plan & 9th Plan)-004-Establishment of a new college including diversification of essential courses of study in existing colleges-30-Grants-in-aid-01-Salary Grants" in the State Budget during the current financial year (Code Number : "2202-03-900-SP-004-01-01").

The college shall be governed by the West Bengal (payment of Salaries) Act, 1978.




